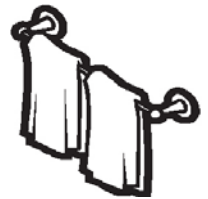
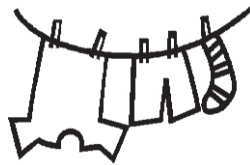

IMPORTANT NOTE:

The following lists are not all-inclusive; they are intended to provide you with basic guidelines for determining whether your items are marketable at auction. The “Do” list assumes the item is in saleable condition. An “antique” is generally defined as something that is at least 100 years old. AAR and its employees reserve the right to accept or decline any item brought in for consideration, either by itself or as part of an estate, regardless of whether or not it appears on these lists.

Examples of Items We DO NOT Consider Appropriate for Auction



- ⊗ Leftover tag sale items
- ⊗ Used mattresses, boxsprings or carpeting
- ⊗ Used contemporary linens (sheets, towels, etc.)
- ⊗ Post 1940's furniture in fair or poor condition
- ⊗ Particle-board or laminate furniture
- ⊗ Contemporary “knick-knacks”
- ⊗ Encyclopedia sets and paperback books
- ⊗ Contemporary magazines
- ⊗ Outdated or inoperational TVs, VCRs, A/Cs
- ⊗ Appliances (washers, dryers, dishwashers, etc.)
- ⊗ Non-vintage clothing (generally post-1940's)
- ⊗ Inexpensive everyday dishes, glassware, etc.
- ⊗ Newer collectibles (Franklin Mint plates, etc.)
- ⊗ Contemporary posters and framed prints

Examples of Items We DO Consider Appropriate for Auction



- ✓ Antique furniture, rugs, lamps and accessories
- ✓ Clean, well-made contemporary furniture, particularly brands like Ethan Allen
- ✓ Older collectible figurines (Royal Doulton, etc.)
- ✓ Pre-1930's glassware and china
- ✓ Original artwork by well-established artists
- ✓ Antique artwork (oils, watercolors, etchings)
- ✓ Antique/vintage collectibles, jewelry, books
- ✓ Authentic movie, sports or other memorabilia
- ✓ Collectible coins & stamps
- ✓ Historical items and paper ephemera
- ✓ High-quality garden accessories and furniture
- ✓ Antique name-brand tools (Stanley, etc.)
- ✓ Vehicles, including boats, RVs and ATVs
- ✓ Heavy equipment
- ✓ Real estate

Again, these lists are only intended to serve as a general guideline for completing the self-evaluation form. If you are still unsure, just list the item with the rest of your merchandise and we will evaluate it for you.
