ABSENTEE BID TERMS

Absentee bids are handled by an Absolute Auctions & Realty (AAR) staff member who bids competitively on the absentee bidder's behalf. These bids are treated fairly and confidentially. By signing these terms, absentee bidders agree to the following guidelines:

- Absentee bids will be executed according to the catalog lot number (also indicated in red on the lot tag). When completing the bidding portion of the bid sheet, absentee bidders must CLEARLY print lot numbers and price per each lot.
- **Absentee bidders are solely responsible for errors on their bid forms and will be considered the purchaser.** After paying for the items, the absentee bidder has the option of either removal or reconsignment to a future auction, which would be subject to the terms of AAR's standard consignment agreement.
- In general, bids usually start with the live audience. However, if the floor does not open the bidding at a reasonable amount, the absentee bid staff person has the discretion to open the item at 50% of the absentee bidder's maximum bid. EXCEPTIONS: If multiple absentee bids of differing amounts are received on a lot, the bidding will open at one bid level above the second-highest bid. This is done to eliminate the underbidder and allow the highest absentee bidder to begin participating. If multiple absentee bids of the same amount are received on a lot, the first one received will take precedence.
- If the bidding falls in such a way that a "live" bidder bids the same amount as the maximum bid of an absentee bidder, it is the policy of AAR to bid once more time on behalf of the absentee bidder so that the lot is not lost at the exact amount of the absentee bidder's maximum limit. This is known as "bidding one over."
- No absentee bids will be accepted for under **\$25.00 per lot**. Absentee bids must be received a half-hour prior to the sale of the lot(s) of interest and are subject to the TERMS AND CONDITIONS of the applicable auction.
- Absentee bidders who subsequently attend the auction are advised to refrain from bidding on the lots they left bids for until after the live bidding exceeds the amount left as an absentee bid.
- Successful absentee bidders will be notified on the Monday following the auction. Unless directed otherwise, each absentee bidder's credit card will be charged on the next business day (Tuesday). Payment is to be made immediately upon notification of successful bids. Pickup must be made on or before the Tuesday following the auction. Any unremoved items will be considered abandoned and will be disposed of.
